

The Second Amendment to the Development Agreement for Valley Vista Estates II



AREARA RELE

This second amendment to the development agreement is made and entered into this _6+h day of _5uly _____, 2000, by Douglas County, a political subdivision of the State of Nevada ("County"), John Serpa, the developer of the project known as Valley Vista Estates II ("Developer"), and Indian Hills General Improvement District ("IHGID").

RECITALS

This second amendment of the development agreement for Valley Vista Estates

II is made with reference to the following facts and objectives:

The Developer and the County entered into the development agreement for Valley Vista Estates II that was approved on August 5, 1993 to be effective on August 26, 1993.

The Developer and the County entered into the first amendment to the development agreement that was approved on July 2, 1998 to be effective on July 23, 1998.

The Developer is seeking an amendment that will give an extension of time to file the next final map. This amendment consists of inserting the following language to change the following section of the amended agreement:

2.8 <u>Commencement and Completion Periods</u>: The Developer must commence and complete construction of the subdivision improvements, public facilities, and public utilities as follows: All improvements within the phase must be completed prior to the recording of the final map unless secured pursuant to section 2.5 of this agreement.

Commencement and completion must conform to the requirements set out in the applicable

Nevada Revised Statutes and Douglas County Code. The Project will be completed within 10 years from September 17, 1992. The next final map for a portion of the Project must be recorded on or before January 4, 2001. If a map is recorded by that date, this Agreement will automatically extend the time for an additional one year period from that date within which the next succeeding map for the next succeeding phase must be filed. So long as Developer files each phase within the one year extension period provided in this Agreement, this Agreement will remain in full force and effect. The Developer may request an additional one year extension for the filing of a final map.
