**AMENDMENT TO CONTRACT FOR SERVICES
OF INDEPENDENT CONTRACTOR**

WHEREAS, Douglas County (and by interlocal contract on behalf of the East Fork Fire and Paramedic District) and Carson Valley Medical Center, a Barton Memorial Hospital Facility and an independent contractor, have previously entered into a contract for services for the provision of medical examinations for certain employees and volunteers; and

WHEREAS, Douglas County now desires Carson Valley Medical Center to perform additional or modified services; and

NOW, THEREFORE, the parties mutually agree that the existing contract shall be amended as follows:

1. East Fork Fire and Paramedic District volunteers will received the same, annual physical examination as East Fork paid staff. Juvenile probation officers will be deleted from the physical examination list. Drug and alcohol testing for new EFFPD volunteers and the availability of reasonable suspicion testing will commence upon execution of this amendment, and random drug and alcohol testing of EFFPD volunteers will be performed commencing on January 1, 2001.

2. Addendum A, page 3 is modified to read as follows:

• **SHERIFF'S OFFICE AND EFFPD PAID STAFF AND VOLUNTEERS:**

a. Physicals are due annually.

Testing includes the following:

1. Chem Panel/Lipid
2. Chest X-ray (NRS 617.455 every even year and annually after age 40)
3. EKG Stress Test
4. Hearing Booth Exam
5. Patient's History
6. Pulmonary Function Test
7. Routine Heart Exam
8. Routine Physician's Exam (including Lung Exam)
9. TB Test
10. Urine Dip Stick (No Lab)
11. Vision
12. Completion of CDL Physical Exam Form if necessary
13. Review of respirator certification if applicable
14. Completion of hazardous materials exam if applicable
15. Completion of ambulance attendant license medical report if applicable

volunteers will conducted by the contractor in accordance with 40 C.F.R. Part 40. In addition, contractor will perform reasonable suspicion testing of upon request of the County.

3. All other terms of the contract continue in effect and unamended.
