5 January 9, 1992.

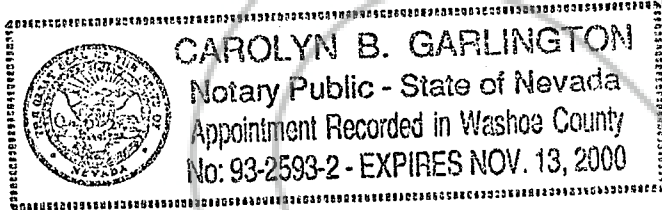
