

NOTICE OF CLAIMS OF LIEN

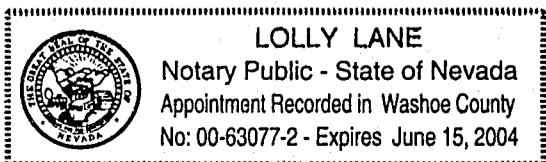
