


Whereas, MICHAEL K. SWIFT AND DORA (TERRY) A. SWIFT,



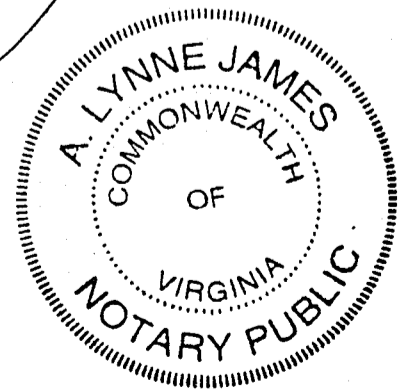
