
SUBSTITUTION OF TRUSTEE AND


Whereas, MICHAEL K. SWIFT AND

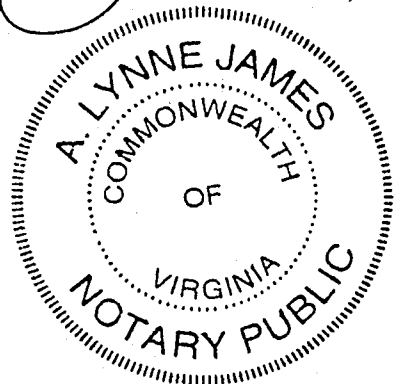
