STIPULATION AND CONFESSION OF JUDGMENT (PRIOR TO SUIT)

1. LINDA L. SOWLE AND GEORGE L. SOWLE , the above named Defendant(s), do hereby state, agree, stipulate, confess and authorize the entry of judgment against them in the amount of \$8,950.42, plus interest accrued thereon in the amount of \$1,076.99, and attorney's fees in the amount of \$250.00, along with Plaintiff's costs of suit \$18.00 for filing of the Stipulation, together with interest to continue to accrue on the principal balance at the mutually agreed contract rate of 24% per annum from the April 27, 2000, until this Judgment is satisfied in full.

2. The Defendant(s) further agrees and stipulates that if, and in the event, that they do not fully pay the above-mentioned sum pursuant to the payment schedule described below, any payments received by the Plaintiff prior to default of the below payment schedule shall be filed as partial satisfaction of this judgment.

3. The Defendant(s) further states, agrees, stipulates, and confesses that authorization for this entry of judgment is for a debt justly due the Plaintiff as a result of a

1 credit/charge account, provided to the Defendant by the Plaintiff, at the special instance and
2 request of the Defendant(s). Defendant(s) further confesses and agrees that they defaulted in
3 payment to the Plaintiff on or about September 24, 1999. The Defendant(s) acknowledges and
4 agrees that after all adjustments have been made upon said account, the balance owed to the
5 Plaintiff by the Defendant(s) are in the amount of \$10,295.41, plus costs, interest and
6 attorney's fees as set out above.


7 4. PAYMENT SCHEDULE: Defendant(s) shall pay the aforesaid obligation as
8 follows: Payments shall be made in an amount of no less than \$53.57 per month by the 25th
9 day of every month starting May 25, 2000, with the first payment of \$53.57 being due no later
10 than May 25, 2000.


11 5. It is expressly understood by the Defendant(s) that the Plaintiff reserves the right
12 to review the agreed upon arrangement every ninety (90) days, after which time the Plaintiff
13 may exercise their right to increase the payment arrangement. In the event that the Plaintiff
14 increases said payment arrangement, the Plaintiff shall give the Defendant the legally required
15 thirty (30) days notice before the new arrangement goes into effect.

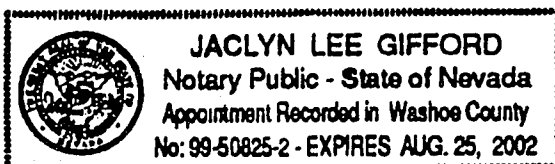
16 6. It is further understood and agreed to by the Defendant(s) that there is no grace
17 period, and that if the Plaintiff has not received payment as previously stipulated, the terms of
18 this agreement will no longer be in effect. Thereafter, Plaintiff may obtain an execution from
19 the Court and may demand payment in full on the remaining Judgment balance.

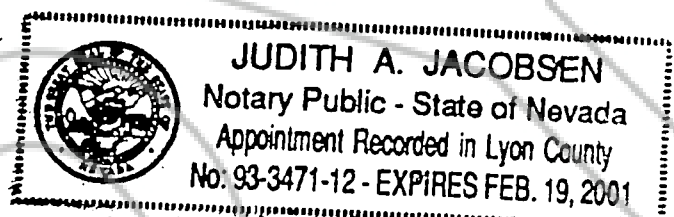

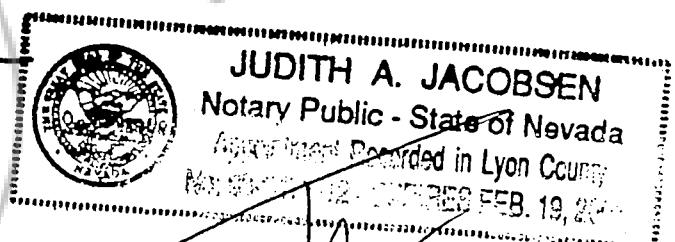

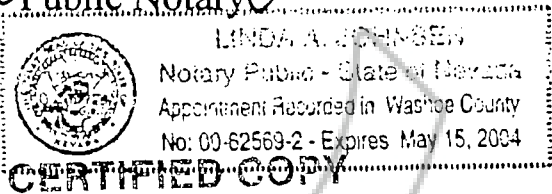
