**ORDER IMPOSING LIEN ON REAL
PROPERTY**

17 THIS MATTER came before the Court this date upon the Petition of the STATE OF
18 NEVADA, DEPARTMENT OF HUMAN RESOURCES, WELFARE DIVISION, and MIKE
19 WILLDEN, Administrator, on behalf of Nevada State Welfare Division, by and through
20 FRANKIE SUE DEL PAPA, Attorney General of the State of Nevada. Appearing at the
21 hearing were, Deann Walker, Medicaid Estate Recovery, on behalf of Nevada State Welfare
22 Division, and their attorney CHARLES HILSABECK, Deputy Attorney General and other
23 appearances have been noted The Court having received the evidence finds as follows:

- 24 1. All notices as required by law have been provided.
- 25 2. ELEANOR MYERS, deceased, was the recipient of Medicaid benefits from
26 March 1, 1996 through August 23, 1999, her date of death.
- 27 3. The State of Nevada Medicaid Program provided payment for medical services
28 for the care of ELEANOR MYERS, in the amount of TWENTY-FIVE THOUSAND FIVE
DOLLARS AND EIGHTY-TWO CENTS (25,005.82) through January 11, 2000.
- 4. The amount of the benefits paid may increase as Medicaid providers have until

1 one year from the date of the death of ELEANOR MYERS to bill Medicaid for services
2 rendered.

3 5. The undivided estate of ELEANOR MYERS included real property whose
4 common address is 2432 Tourmaline, Carson City, Nevada 89705, and whose legal
5 description is as follows:

6 Lot 16, as shown on the Official Map of RIDGEVIEW ESTATES,
7 filed for record in the offices of the County Recorder of Douglas
8 County, Nevada, on December 27, 1972, as Document No. 63503.
9 APN 13-164-04

10 6. The estimated value of the real property described above is THIRTY FIVE
11 THOUSAND TEN DOLLARS (\$35,010).

12 7. The imposition of a lien upon the above described real property of ELEANOR
13 MYERS, a deceased Medicaid recipient, by the Nevada State Welfare Division is authorized
14 and appropriate pursuant to Nevada Revised Statutes.


15 8. The imposition of a lien in the amount TWENTY-FIVE THOUSAND FIVE
16 DOLLARS AND EIGHTY-TWO CENTS (25,005.82), which represents the amount of
17 assistance paid on behalf of ELEANOR MYERS, a Medicaid recipient, by the Nevada State
18 Welfare Division is authorized and appropriate pursuant to Nevada Revised Statutes.

19 THEREFORE, based upon the foregoing, IT IS HEREBY ORDERED ADJUDGED AND
20 DECREED AS FOLLOWS:

21 A lien, on behalf of the NEVADA STATE WELFARE DIVISION, MEDICAID
22 PROGRAM, in the amount of TWENTY-FIVE THOUSAND FIVE DOLLARS AND EIGHTY-
23 TWO CENTS (25,005.82) is hereby imposed against the real property of the undivided estate
24 of ELEANOR MYERS, whose common address is 2432 Tourmaline, Carson City, Nevada
25 89705, and whose legal description is as follows:

26 Lot 16, as shown on the Official Map of RIDGEVIEW ESTATES,
27 filed for record in the offices of the County Recorder of Douglas
28 County, Nevada, on December 27, 1972, as Document No. 63503.
