SUBORDINATION AGREEMENT

WHEREAS, Owner has executed, or is about to execute, a deed of trust and note in the sum of \$30,700.00, dated September 19, 2000, in favor of Wells Fargo Home Mortgage, Inc., hereinafter referred to as "Lender," payable with interest and upon the terms and conditions described therein, which deed of trust will record concurrently herewith on 99900, in Book 0900, Official Records, Page 9900, as Document No. 99000 and

WHEREAS, it is a condition precedent to obtaining said loan from Lender that said deed of trust last above mentioned shall unconditionally be and remain at all times a lien or charge upon the land hereinbefore described, prior and superior to the lien or charge of the deed of trust first above mentioned; and
