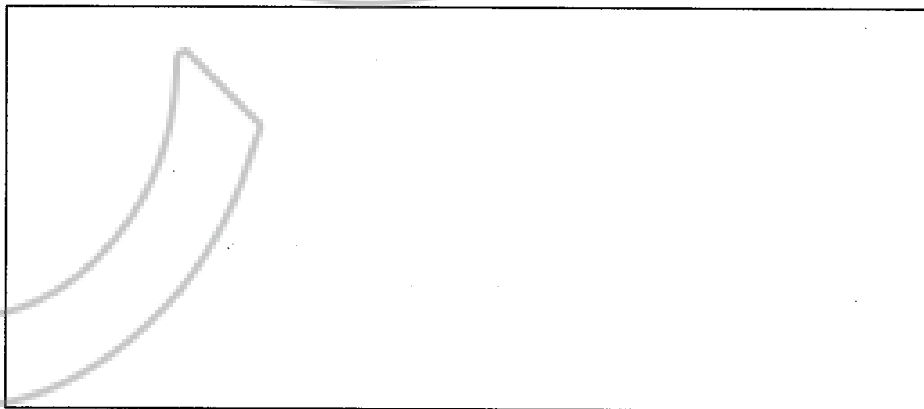
This lien results from a child support order, entered on 10/27/93 by SUPERIOR COURT

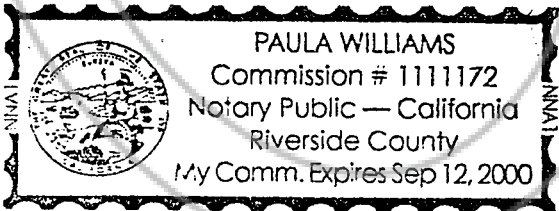
