# MODIFICATION OF DEED OF TRUST

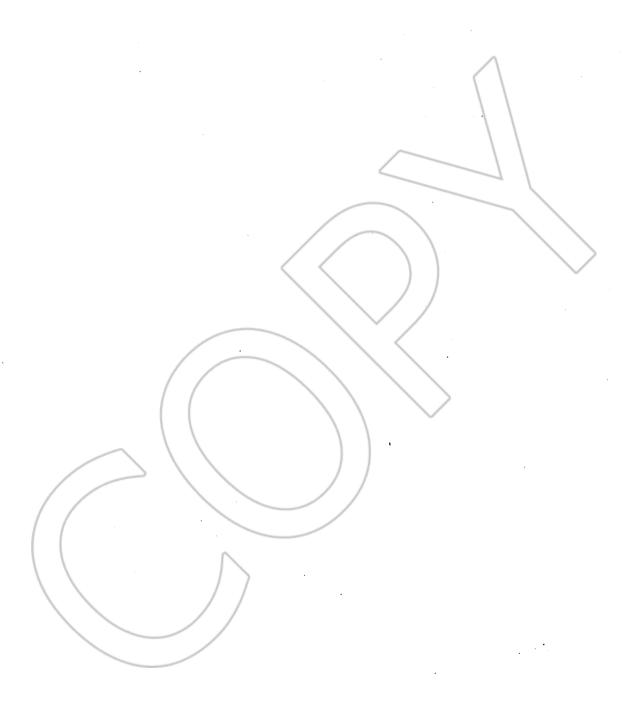
