

the person or persons legally entitled thereto, the estate now held by it under said Deed of Trust.



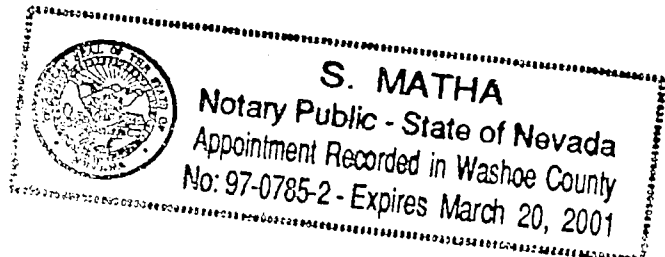
