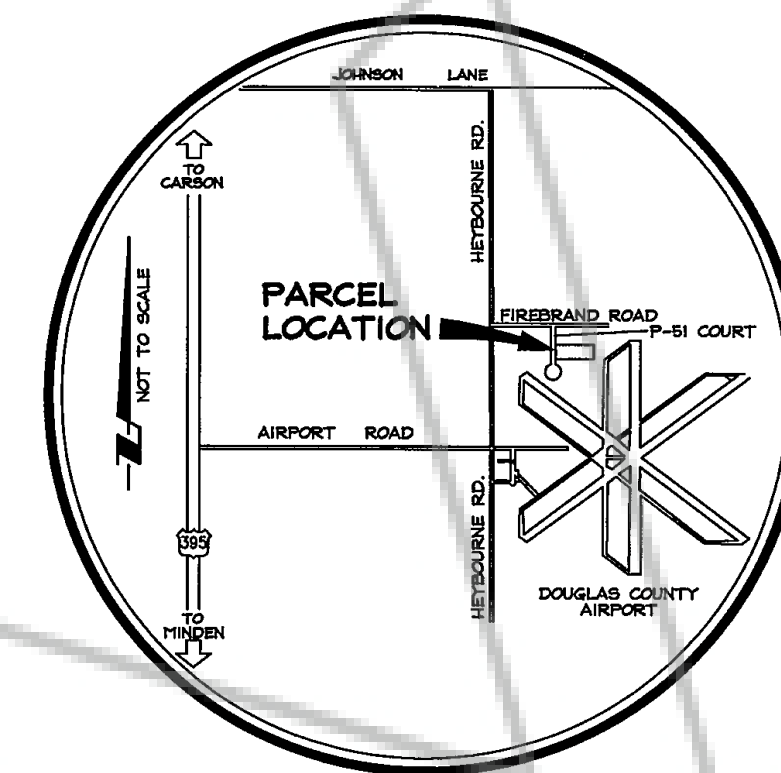


FIREBRAND CIRCLE

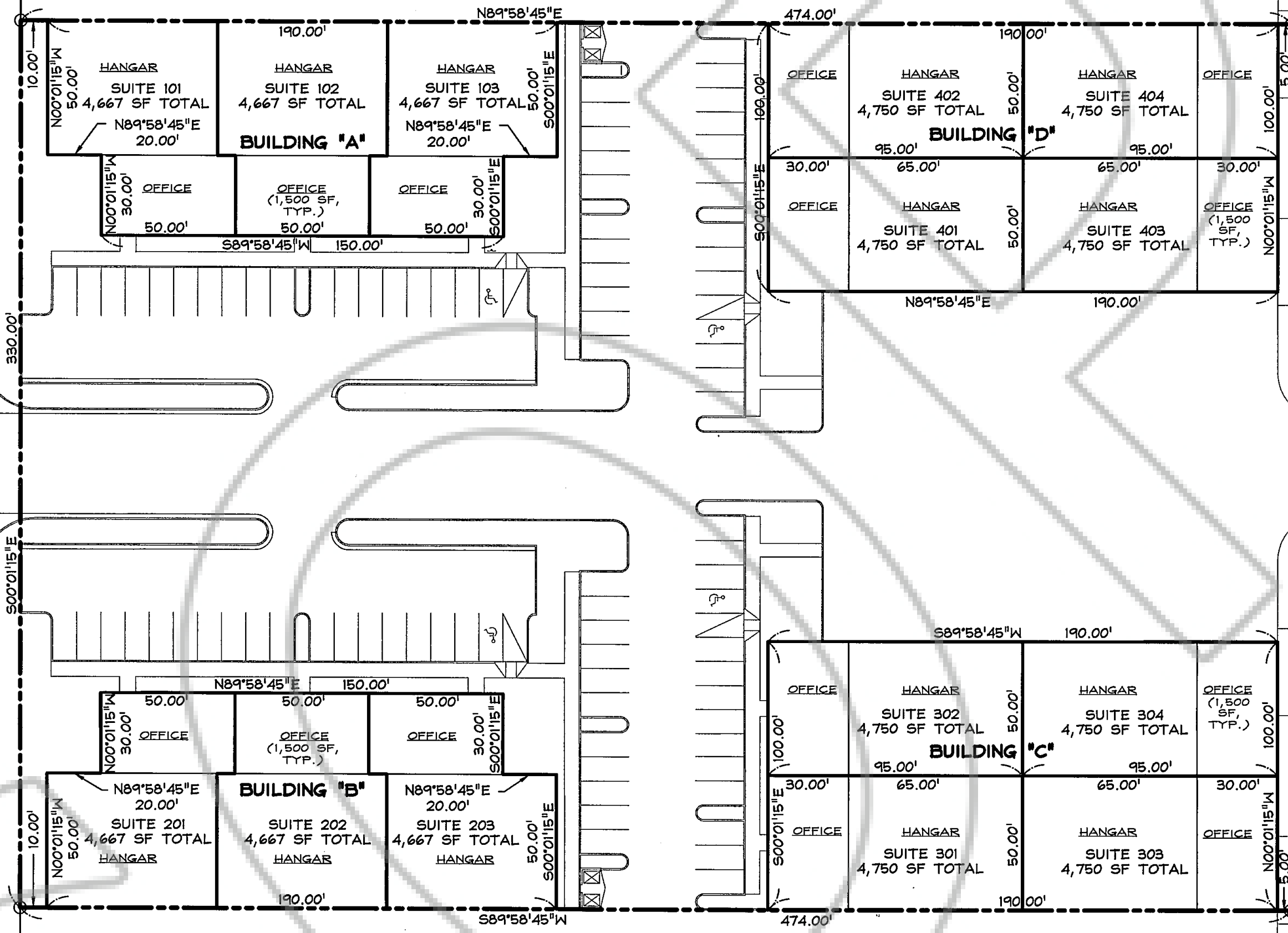
TAXI LANE

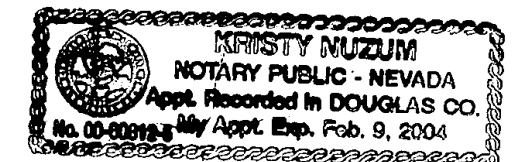
