All other property described in said Deed of Trust continues to be held by said Trustee under the terms thereof.

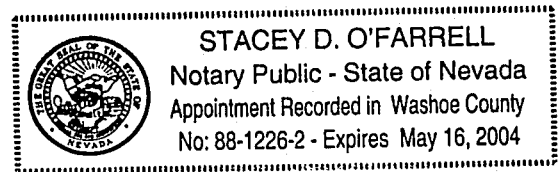
