16 **SUMMARY JUDGMENT IN FAVOR OF PLAINTIFF**

17 WHEREAS, the Plaintiff agreed to loan the Defendant the amount of
18 \$15,785.60, in order to finance the Defendant's 1991 Ford 4X2 automobile with the
19 Vehicle Identification Number 1FTHX25G8MKA43415; and

20 WHEREAS, the Defendant thereafter failed to make the agreed upon monthly
21 payments pursuant to the terms of the parties' agreement, and has failed to return
22 the Vehicle.

23 WHEREAS, on November 3, 2000, an Order was entered by this Court granting
24 Plaintiff's Motion for Summary Judgment.

25 NOW, THEREFORE, it is hereby ORDERED and DECREED as follows:

26 1 Plaintiff's Motion for Summary Judgment is hereby granted.

27 2. Judgment is hereby entered in favor of the Plaintiff and against the
28 Defendant in the amount of \$4,614.09, (\$2,767.24 in unpaid principal, \$717.85 in

1 pre-judgment interest and \$1,129.00 in fees and late charges) plus interest on the
2 principal balance at the contract rate of 9.99% (a per diem of \$.75) until satisfied,
3 and costs in the amount of \$319.70, together with attorney's fees in the amount of
4 \$ 1,153.52.

5 Judgment having been submitted to the Court for consideration and good
6 cause appearing therefore,

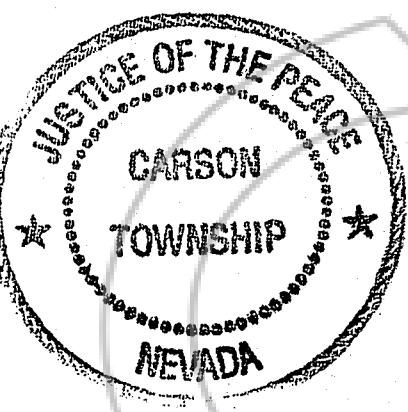
