20 court having considered the Defendant's stipulation to the issues, evidence and judgment, and  
21 having considered plaintiff's Application for Attorney's Fees, it is hereby

23 **ORDERED, ADJUDGED AND DECREED** that Plaintiff has judgment against the  
24 Defendants in this action for the sum of Seven Hundred and 00/100 Dollars (\$700.00), plus interest

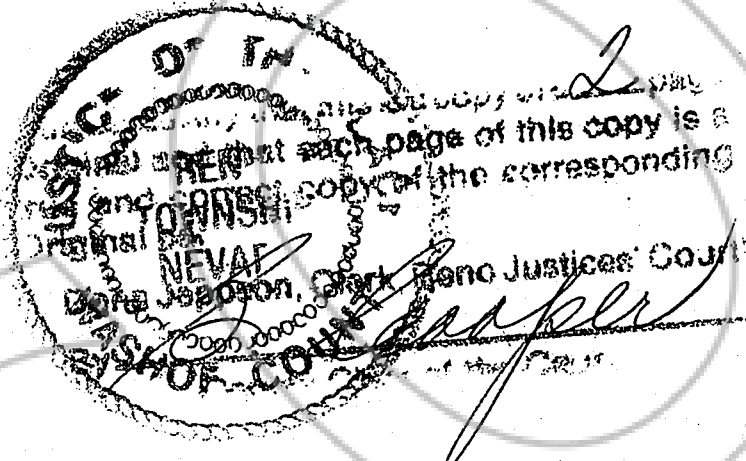
1 per annum, which is a daily rate of \$.22, for total accrued interest of \$31.94 through the date of trial.
