
Whereas, MARC DURYEE AND NOREEN DURYEE, HUSBAND AND WIFE



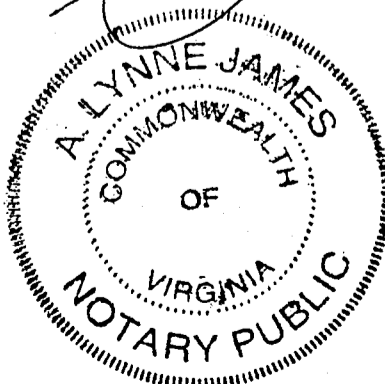
