4 Commencing October 30, 2000, \$100.00 per month for a period of 6 months, then  
5 commencing April 30, 2001, \$135.00 per month for a period of 6 months, then  
6 commencing October 30, 2001, \$200.00 per month for a period of 12 months, then  
7 commencing October 30, 2002, \$275.00 per month due on or before the 30th day  
8 of each month and continuing thereafter until paid in full.




