ORDER IMPOSING LIEN ON REAL PROPERTY

THIS MATTER came before the Court this date upon the Petition of the STATE OF NEVADA, DEPARTMENT OF HUMAN RESOURCES, WELFARE DIVISION, and MIKE WILLDEN, Administrator, on behalf of Nevada State Welfare Division, by and through FRANKIE SUE DEL PAPA, Attorney General of the State of Nevada. Appearing at the hearing CHARLES HILSABECK, Deputy Attorney General and other appearances have been noted. The Court having received the evidence finds as follows:

- 1. All notices as required by law have been provided.
- 2. MARJORIE COTTOM, deceased, was the recipient of Medicaid benefits from October 11, 1993 through July 16, 1999, her date of death.
- 3. The State of Nevada Medicaid Program provided payment for medical services for the care of MARJORIE COTTOM, in the amount of NINETEEN THOUSAND ONE

HUNDRED THIRTEEN DOLLARS AND NINETY-SEVEN CENTS (\$19,113.97) through November 22, 1999.

- 4. The amount of the benefits paid may increase as Medicaid providers have until one year from the date of the death of MARJORIE COTTOM to bill Medicaid for services rendered.
- 5. The undivided estate of MARJORIE COTTOM included real property whose common address is 1344 Toiyabe, Gardnerville, Nevada and whose legal description is as follows:

Lot 6, as shown on the official FINAL MAP OF CARSON VALLEY ESTATES SUBDIVISION UNIT NO. 2, filed for record in the office of the County Recorder of Douglas County, Nevada, on December 23, 1970, as Document no. 50685.

- 6. The estimated value of the real property described above is SEVENTY TWO THOUSAND TWO HUNDRED TEN DOLLARS AND NO CENTS (\$72,210.00).
- 7. The imposition of a lien upon the above-described real property of MARJORIE COTTOM, a deceased Medicaid recipient, by the Nevada State Welfare Division is authorized and appropriate pursuant to Nevada Revised Statutes.
- 8. The imposition of a lien in the amount of NINETEEN THOUSAND ONE HUNDRED THIRTEEN DOLLARS AND NINETY-SEVEN CENTS (\$19,113.97), which represents the amount of assistance paid on behalf of MARJORIE COTTOM, a Medicaid recipient, by the Nevada State Welfare Division is authorized and appropriate pursuant to Nevada Revised Statutes.

THEREFORE, based upon the foregoing, IT IS HEREBY ORDERED ADJUDGED AND DECREED AS FOLLOWS:

A lien, on behalf of the NEVADA STATE WELFARE DIVISION, MEDICAID PROGRAM, in the amount of NINETEEN THOUSAND ONE HUNDRED THIRTEEN DOLLARS AND NINETY-SEVEN CENTS (\$19,113.97), is hereby imposed against the real property of the undivided estate of MARJORIE COTTOM, whose common address is 1344 Toiyabe, Gardnerville, Nevada, and whose legal description is as follows:
