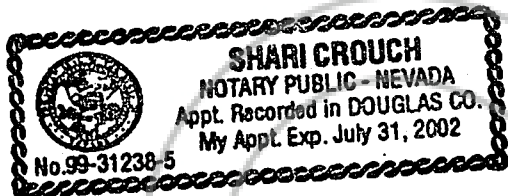
PARTIAL RECONVEYANCE


