
SUBSTITUTION OF TRUSTEE AND

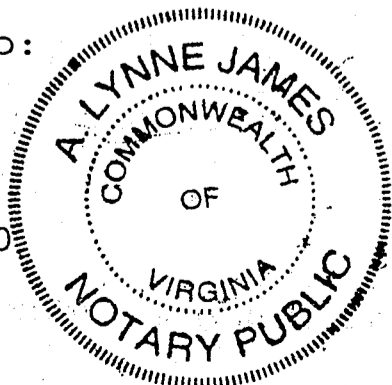
