AMENDMENT NO. 3
Contract Between Douglas County
and
JWA Consulting Engineers, Inc.
Douglas County Transfer Station and Recycle Center Project

Whereas, on October 11, 1999, Douglas County, a political subdivision of the State of Nevada, and JWA Consulting Engineers, Inc., an independent contractor, entered into a contract for Contractor to provide engineering services for design of the Douglas County Transfer Station, design of improvements to the Fairgrounds Pump Station, design of a new water storage tank, and design of approximately 3,125 feet of off-site water line; and

Whereas, on December 30, 1999 the County Manager approved Amendment No. 1 to delete work related to the storage tank project, pump station project, and water line project; and

Whereas, on May 19, 2000 the County Manager approved Amendment No. 2 to provide a water line easement; and

Whereas, additional engineering services were required to provide access to the shooting range, provide options for trailer parking, and provide a bid alternate for a reduced floor plan; and

Whereas, engineering services were not required for optional design items related to a masonry block building; and

Now, therefore, in consideration of the agreements herein made, the parties mutually agree as follows:

- The scope of services for the Transfer Station and Recycle Center Task is amended to include engineering services to provide access to the shooting range, provide options for trailer parking, and provide a bid alternate for a reduced floor plan at a cost not to exceed \$12,070.00.
- The scope of services for optional design items is deleted from the Transfer Station and Recycle Center Task, and compensation is reduced by \$12,070.00.
- Contractor agrees to provide the services set forth in the contract, Amendment No. 1, Amendment No. 2, and this Amendment No. 3 for a cost not to exceed a total cost of \$279,900.
