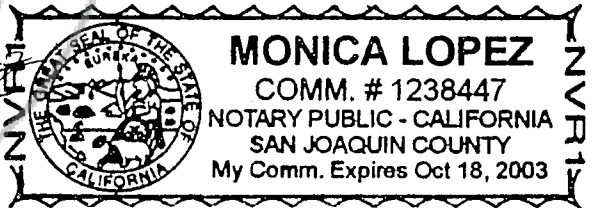

Parcel One:

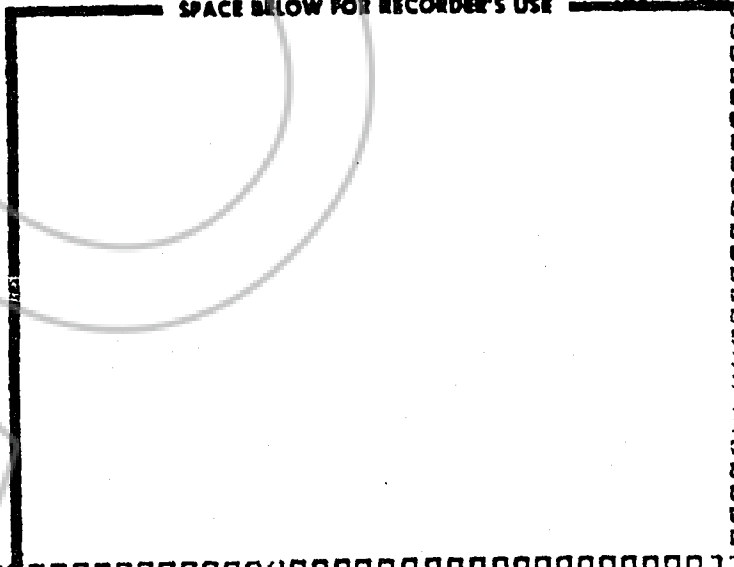
Parcel Five:
