The STATE OF NEVADA, DEPARTMENT OF HUMAN RESOURCES, WELFARE DIVISION (hereinafter referred to as Nevada State Welfare Division), by and through FRANKIE SUE DEL PAPA, Attorney General, and her Deputy Attorney General, CHARLES HILSABECK, hereby agrees with VICTOR E. BERGSTROM, Administrator of the Estate of AGNES W. PRATT, as follows:

WHEREAS, AGNES W. PRATT applied for and received Medicaid benefits through the Nevada State Welfare Division; and

WHEREAS, the Nevada State Welfare Division paid FORTY-ONE THOUSAND NINE HUNDRED FORTY-SIX DOLLARS and 91/100 (\$41,946.91) in Medicaid benefits to AGNES W. PRATT as of August 14, 2000; and

WHEREAS, the amount of benefits paid is not expected to increase; and

WHEREAS, the amount of the lien will not increase if the amount of benefits paid increases;

and

WHEREAS, AGNES W. PRATT died on April 26, 2000; and

WHEREAS, pursuant to Nevada Revised Statute 422.2935, the Nevada State Welfare Division has a statutory claim upon the Estate of AGNES W. PRATT for Medicaid benefits paid on her behalf; and

WHEREAS, AGNES W. PRATT, decedent, owned real property located at 1364 Elges Avenue, Gardnerville Nevada, A.P.N. 1220-04-515-017, more particularly described as follows:

Lot 40, as shown on that certain map entitled "FINAL MAP OF CARSON VALLEY ESTATES SUBDIVISION UNIT NO. 3," filed for record in the Office of the Recorder of Douglas County, State of Nevada, on September 15, 1971, in Book 2 of Maps, at Page 257, under Document No. 54454;

WHEREAS, VICTOR E. BERGSTROM has been appointed as the Administrator of the Estate of AGNES W. PRATT; and

WHEREAS, VICTOR E. BERGSTROM agrees that the property should be included in the undivided Estate of AGNES W. PRATT; and

WHEREAS, Nevada Revised Statute 422.29355 provides for the Nevada State Welfare Division to impose a lien upon real property or personal property of a Medicaid recipient or her estate, including property that was held as joint tenancy, pursuant to Nevada Revised Statute 422.054; and

WHEREFORE, IT IS HEREBY AGREED that the Nevada State Welfare Division shall have a lien in the amount of FORTY-ONE THOUSAND NINE HUNDRED FORTY-SIX DOLLARS and 91/100 (\$41,946.91) against the subject property located at 1364 Elges Avenue, Gardnerville, Nevada, APN. 1220-04-515-017, being more particularly described as follows:

Lot 40, as shown on that certain map entitled "FINAL MAP OF CARSON VALLEY ESTATES SUBDIVISION UNIT NO. 3," filed for record in the Office of the Recorder of Douglas County, State of Nevada, on September 15, 1971, in Book 2 of Maps, at Page 257, under Document No. 54454.
