Together with all and singular the tenements, hereditaments, and appurtenances thereunto belonging or in anywise appertaining.

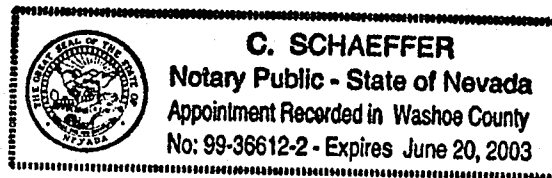
