- 3. The State of Nevada Medicaid Program provided payment for medical services for the care of Raymond Bozulich, in the amount of TWENTY SIX THOUSAND ONE

HUNDRED THIRTY DOLLARS AND EIGHTY-FOUR CENTS (\$26,130.84) through September 2, 2000.

- 4. The amount of the benefits paid may increase as Medicaid providers have until one year from the date of the death of Raymond Bozulich to bill Medicaid for services rendered.
- 5. On or about April 3, 2001, Henry Cavallera, attorney for Mary Bozulich, submitted a check in the amount of EIGHT THOUSAND EIGHT HUNDRED THIRTY-ONE DOLLARS AND TWENTY-SEVEN CENTS (\$8,831.27) as partial reimbursement for benefits paid on behalf of Raymond Bozulich.
