**ORDER IMPOSING LIEN  
ON REAL PROPERTY**

17 THIS MATTER came before the Court this date upon the Petition of the STATE OF  
18 NEVADA, DEPARTMENT OF HUMAN RESOURCES, WELFARE DIVISION, and MIKE  
19 WILLDEN, Administrator, on behalf of Nevada State Welfare Division, by and through  
20 FRANKIE SUE DEL PAPA, Attorney General of the State of Nevada. Appearing at the  
21 hearing CHARLES HILSABECK, Deputy Attorney General and other appearances have been  
22 noted. The Court having received the evidence finds as follows:

- 23 1. All notices as required by law have been provided.  
24 2. RAYMOND BOZULICH, deceased, was the recipient of Medicaid benefits from  
25 May 4, 1999 through April 27, 2000, his date of death.  
26 3. The State of Nevada Medicaid Program provided payment for medical services  
27 for the care of Raymond Bozulich, in the amount of TWENTY SIX THOUSAND ONE

1 HUNDRED THIRTY DOLLARS AND EIGHTY-FOUR CENTS (\$26,130.84) through  
2 September 2, 2000.

3 4. The amount of the benefits paid may increase as Medicaid providers have until  
4 one year from the date of the death of Raymond Bozulich to bill Medicaid for services  
5 rendered.

6 5. On or about April 3, 2001, Henry Cavallera, attorney for Mary Bozulich,  
7 submitted a check in the amount of EIGHT THOUSAND EIGHT HUNDRED THIRTY-ONE  
8 DOLLARS AND TWENTY-SEVEN CENTS (\$8,831.27) as partial reimbursement for benefits  
9 paid on behalf of Raymond Bozulich.

10 6. The undivided estate of Raymond Bozulich included real property whose  
11 common address is 2673 Vicky Lane, Minden, Nevada 89423 and whose legal description is  
12 as follows:

13 Parcel B, as shown on the parcel map for John T. and Gary Bidwell  
14 filed in the office of the County Recorder of Douglas County,  
15 Nevada, on July 20, 1976, in Book 776 of Official Records as page  
1023.

16 7. The estimated value of the real property described above is ONE HUNDRED  
17 TWENTY SEVEN THOUSAND FIVE HUNDRED TWENTY-SEVEN DOLLARS AND NO  
18 CENTS (\$127,527.00).

19 8. The imposition of a lien upon the above described real property of Raymond  
20 Bozulich, a deceased Medicaid recipient, by the Nevada State Welfare Division is authorized  
21 and appropriate pursuant to Nevada Revised Statutes.

22 9. The imposition of a lien in the amount of SEVENTEEN THOUSAND TWO  
23 HUNDRED NINETY-NINE DOLLARS AND FIFTY-SEVEN CENTS (\$17,299.57), which  
24 represents the amount of assistance paid on behalf of Raymond Bozulich, a Medicaid  
25 recipient, by the Nevada State Welfare Division, less the reimbursed amount of EIGHT  
26 THOUSAND EIGHT HUNDRED THIRTY-ONE DOLLARS AND TWENTY-SEVEN CENTS  
27 (\$8,831.27), is authorized and appropriate pursuant to Nevada Revised Statutes

1 THEREFORE, based upon the foregoing, IT IS HEREBY ORDERED ADJUDGED AND  
2 DECREED AS FOLLOWS:

3 A lien, on behalf of the NEVADA STATE WELFARE DIVISION, MEDICAID  
4 PROGRAM, in the amount of SEVENTEEN THOUSAND TWO HUNDRED NINETY-NINE  
5 DOLLARS AND FIFTY-SEVEN CENTS (\$17, 299.57), is hereby imposed against the real  
6 property of the undivided estate of Raymond Bozulich, whose common address is 2673 Vicky  
7 Lane, Minden, Nevada, 89423 and whose legal description is as follows:
