## SUBORDINATION AGREEMENT Ocwen Loan # 88944012

THIS AGREEMENT is entered into this <u>Job</u> day of March 2001, by Wells Fargo Home Mortgage, Inc. ("WFHM"), David A. Silverberg and Cheryl Qualls & Empire Funding Corp.

## Recitals

Lienholder holds a second deed of trust originally granted by First Financial Funding Group, dated July 28, 1998 and recorded August 13, 1998, in Book 898, Page 2777, as Document No. 447016 of Official Records, to secure an original indebtedness of \$36,500. Said Mortgage was subsequently assigned to Empire Funding Corp., by assignment recorded August 13, 1998, in Book 898, Page 2784, as Document No. 447017 of Official Records, securing an interest in the following described real estate ("the Property"):

This agreement subordinates a Mortgage/Deed of Trust from DAVID A. SILVERBERG in the amount of \$36,500.00 held by EMPIRE FUNDING CORP., to a Mortgage/Deed of Trust to WELLS FARGO HOME MORTGAGE, INC. not to exceed \$133,200.00, at a fixed rate of 7 %, for a term of at least 360 months.

(now known as Wells Fargo Home Mortgage, Inc.), dated August 20, 1997 and recorded August 27, 1997 in Book 897, Page 4302, as Document No. 420071 of Official Records, to secure an original indebtedness of \$132,089.00, securing an interest in the following property described above.

WFHM will provide credit to refinance the first deed of trust secured by the Property if Lienholder subordinates its second deed of trust lien to WFHM's new first deed of trust lien in the amount of \$133,200.00.

NOW THEREFORE, in consideration of the covenants contained herein, the parties agree as follows:

- 1. <u>Subordination</u>. Lienholder agrees to and hereby does subordinate its second deed of trust lien in the Property to a new first deed of trust lien to be filed by **WFHM** in order to refinance **WFHM's** existing first deed of trust.
- 2. <u>Effect</u>. **WFHM** agrees that Lienholder's second deed of trust shall in no way be impaired or affected by this Agreement except that the second deed of trust lien shall stand junior and subordinate to the **WFHM** new first deed of trust in the same manner and to the same extent as if the **WFHM** new first deed of trust had been filed prior to the execution and recording of the Lienholder's second deed of trust.
