Amendment to Covenants, Conditions, and Restrictions for BRANDI ROSE WAY

The undersigned, representing 60% of the property owners do hereby agree to the following amendment to the Declaration of Resstrictions recorded October 23, 2000, in Book 1000, at Page 4319, as Document No. 501888, Official Records of Douglas County, Nevada:

The following paragraph shall be added to said restrictions:

No livestock, fowl, or other animals other than dogs, cats, or other common and ordinary household pets may be kept on any lot in the subdivision. No household pets or other animals whatsoever will be kept or bred for commercial purposes on any parcels or lots. Furthermore, household pets shall not interfere with the reasonable comfort or safety of adjoining neighbors and shall not exceed a total of three (3) such pets per household.
