AN ORDER OF ABANDONMENT VACATING A PUBLIC ROAD RIGHT-OF-WAYAR A REED

Douglas County, a political subdivision in the state of Nevada, presently holds an easement interest within the west half of the northeast one-quarter of Section 32, Township 13 North, Range 20 East, MDM, a portion of the existing road right-of-way commonly known as County Road, approximately 500 feet in length extending to the west of U.S. Highway 395, and the easement is more specifically described on the legal descriptions of County Road Abandonment, attached as Exhibit A, pages 1-6, inclusive; and

Douglas County may vacate or abandon by formal order any portion of a public roadway that is in excess of its needs pursuant to the provisions of NRS 278.480; and

On March 13, 2001, the Douglas County Planning Commission held a public hearing pursuant to NRS 278.240 and found that the abandonment of the described public road easement was not inconsistent with the Douglas County Master Plan; and

On March 15, 2001, the Douglas County Board of Commissioners held a public hearing and found that the subject easement is in excess of the needs of Douglas County, and that the public will not be materially injured by the abandonment;

It is ordered by the Board of Douglas County Commissioners that the public road easement and any incidents, as described on the attached legal descriptions of County Road Abandonment, attached as Exhibit A, pages 1-6, inclusive, is abandoned subject to the following conditions:

- 1. Right-of-way for the realignment of County Road into a "T" intersection shall be dedicated concurrently with the abandonment of the subject portion of County Road.
- 2. Access easements shall be dedicated as shown on the exhibits presented with this application.
- 3. The abandonment shall be consistent with Sections 278.240 and 278.480 of the Nevada Revised Statutes.






