MEMORANDUM OF AGREEMENT

Seller has granted and hereby grants to Purchaser the exclusive right to purchase and Purchaser has agreed and hereby agrees to purchase Seller's right, title and interest in the water rights described in Exhibit "A" (attached hereto and by this reference incorporated herein) on the terms and conditions stated in such Agreement which include, without limitation, application for and receipt of all required regulatory approvals.

The Agreement remains in effect until the purchase is consummated, or it is terminated pursuant to the terms of the Agreement.

DESCRIPTION OF WATER RIGHTS

Sierra Pacific Power Company's water rights to operate run-of-the river hydroelectric facilities in and along the Truckee River, as set forth in and under:

- The 1915 Truckee River General Electric Decree (entered June 4, 1915 by the United States District Court for the Northern District of California in *United States of America v. Truckee River General Electric Co.*, No. 14861, which case was transferred to the United States District Court for the Eastern District of California on February 9, 1968, and is now designated No. S-643) as recognized and confirmed under Claim number 4 of the Orr Ditch Decree (entered January 1, 1944 by the United States District Court for the District of Nevada in *United States of America v. Orr Water Ditch Co.*, et.al, in Equity, Docket No. A3,) and as affected by the Truckee River Agreement (dated July 1, 1935 and entered into by the United States of America, Truckee-Carson Irrigation District, Washoe County Water Conservation District, Sierra Pacific Power Company, and other users of the waters of the Truckee River); and
- Water Rights Claims numbers 5 through 9 under the Orr Ditch Decree (entered January 1, 1944 by the United States District Court for the District of Nevada in *United States of America v. Orr Water Ditch Co.*, et.al, in Equity, Docket No. A3,); and
- Water Rights for hydroelectric generation associated with Donner and Independence Lakes.
