EASEMENT DEED

THIS DEED, made this 4 day of ________, 2001, between DOUGLAS COUNTY, a political subdivision of the State of Nevada, hereinafter called GRANTOR, and the STATE OF NEVADA, acting by and through its Department of Transportation, hereinafter called GRANTEE,

WITNESSETH:
