

**NOTICE OF DEFAULT AND ELECTION TO SELL UNDER DEED OF TRUST**

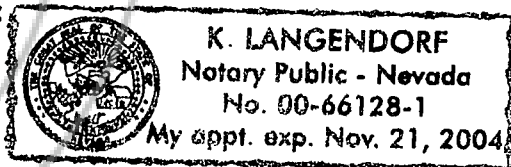
