SHORT FORM DEED OF TRUST WITH ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made JUL 13 01, between NEVADA SMALL ENGINES, INC., A Nevada Corporation, whose address is 1416 Purple Sage Gardnerville, Nv 89410, herein called TRUSTOR, WESTEREN TITLE CO., INC., A NEVADA CORP, herein called TRUSTEE, and Max Hoseit a married man, herein called BENEFICIARY,

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property located in Douglas County, Nv described as:

Lot 13 in Block B of Barrington Ranchos, Filed for record in the office of the county recorder of Douglas County, Nevada on March 1, 1991 in Book 391 page 187 as document No. 245840, being a subdivision of lot 70, as shown on the map of Gardnerville Ranchos Unit # 6, filed for record in the office of the county recorder of Douglas County, Nevada on May 29, 1973, in Book 573, Page 1026, as file No. 66512,

Together with the rights to all governmental permits or licenses of all types and all personal property whether affixed to the property or not which are necessary for the ordinary and intended use of the property, including but not limited to sewer and water hookup rights and water rights. Such rights shall be considered appurtenant to and part of the real property, and the rents, issues and profits of the property, SUBJECT, HOWEVER, to the right, power and authority given to and conferred upon Beneficiary by paragraph (10) of the provisions incorporated herein by reference to collect and apply such rents, issues and profits.

This trust deed shall constitute collateral for aqll loans to the borrower by other lenders of Butler Mortgage Co.

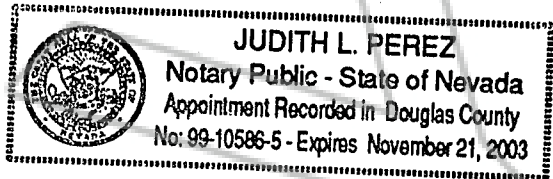
