
**NOTICE OF ATTORNEY'S LIEN**



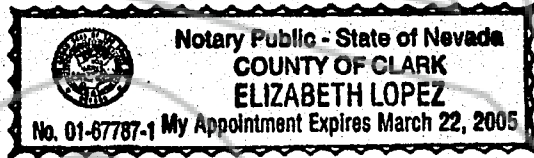
