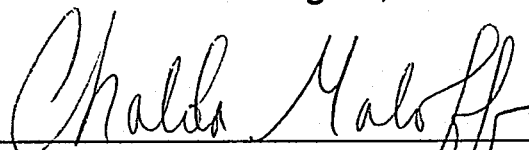
Lot 207, Skyland subdivision No. 3, Assessors Parcel No. 05-052-180 together with any personal property located thereon.

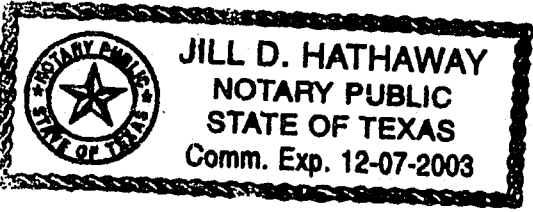
