
WHEREAS the undersigned as the present beneficiary of the Deed of Trust desire to change the Trustee therein, and



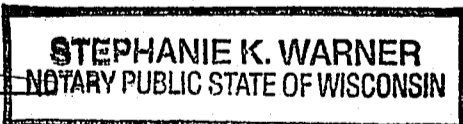
