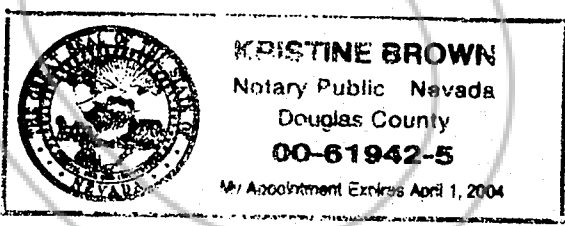

JUDGMENT OF CONVICTION

RONALD L. GILDER,
Defendant,

On August 22, 1995, the defendant above-named appeared before the Court with counsel, Michael J. Roeser, and entered a plea of guilty to the crime of FAILURE TO SUPPORT OR MAINTAIN A CHILD, a gross misdemeanor, in violation of NRS 201.020 committed for a period of six months prior to the filing of the criminal complaint.

On October 3, 1995, the defendant above-named appeared before the Court for sentencing with counsel, Terri Steik Roeser, and the State was represented by Dina Salvucci. No sufficient legal cause was shown by the defendant as to why judgment should

1 not be pronounced against him. The Court adjudged the defendant
2 guilty of the crime of FAILURE TO SUPPORT OR MAINTAIN A CHILD.

3 The Court then sentenced the defendant to imprisonment
4 in the Douglas County Jail for a term of one (1) year. Execution
5 of this term of confinement is suspended and the defendant is
6 placed on formal probation for a period of three (3) years under
7 the terms and conditions of the Probation Agreement and subject
8 to the following special conditions:
9

11 1) the defendant will immediately report any changes in
12 his disability status to the Division of Parole and Probation and
13 to the Douglas County District Attorney's Office;

14 2) in the event that the defendant's disability ceases,
15 he will immediately report to the Division of Parole and
16 Probation and keep them informed of his efforts to obtain gainful
17 employment. Regardless of his employment situation, the
18 defendant will be responsible for the payment of child support as
19 set forth herein;
20

21 3) any disability benefits paid to the children by a
22 third party, whether Social Security or other disability benefit,
23 shall be applied toward ongoing child support obligation of
24 \$150.00 per month per child, for a total of \$300.00 per month;
25

26 4) at this time, the children are receiving \$144.00 per
27 month per child, for a total of \$288.00 per month from Social

1 Security disability benefits. The defendant will take whatever
2 steps are necessary to ensure that the children continue to
3 receive Social Security disability benefits, or any other
4 disability benefit that the defendant may be entitled to so long
5 as the defendant is disabled;

7 5) upon the emancipation of the oldest child, Casey Lee
8 Gilder, born March 30, 1979, but in no event later than June 1,
9 1998, the defendant shall immediately begin to pay, to the
10 Douglas County Clerk, \$100.00 per month toward then existing
11 child support arrearages. The defendant shall continue to pay
12 \$100.00 per month until all child support arrearages have been
13 paid in full. The child support arrearages at the present time
14 are \$21,254.00;

17 6) in the event the defendant obtains gainful
18 employment he will immediately report it to the Division of
19 Parole and Probation and the Douglas County District Attorney's
20 Office for the purpose of initiating wage withholding. The
21 defendant understands that he is responsible for all child
22 support payments as required by this Judgment of Conviction;

24 7) the defendant shall keep the Douglas County District
25 Attorney's Office informed of his residence, employment, and
26 family status.
