That in the above-mentioned Order, judgment was

entered in favor of the Plaintiff and against Defendant in the

amount of \$4,004.26 for child support arrears through November 30, 1991.

- 3. That the Defendant is current with his ongoing child support obligation having paid all arrears through May
- 4. That ABIGAIL has emancipated which leaves remaining, ANNA, DANIEL AND KAITLIN who are entitled to support from the Defendant.
- 5. That Defendant currently earns \$4,333.00 per month, working for Lake Tahoe Community College. Based upon Defendant's monthly income and applying the formulas set forth in NRS 125B.070, to wit: 29%, for the support of three children, Defendant's monthly child support obligation is \$1,256.00.
- 6. That, however, ANNA will emancipate in June of 1998, which will leave DANIEL and KAITLIN the only two remaining minor children of the parties who are entitled to support.
- 7. Based upon Defendant's monthly income and applying the formulas set forth in NRS 125B.070, to wit: 25% for the support of two children, Defendant's monthly child support obligation is \$1,083.00.
- 8. That, however, Defendant and Plaintiff agree, that Defendant's ongoing child support obligation may be adjusted due to the amount of time Defendant spends with the children, and the cost of medical insurance which is provided by the Defendant for the benefit of the children. Also, Plaintiff has

agreed to a lower ongoing child support obligation in settlement and compromise of the parties respective claims.

- 9. Therefore, Defendant shall pay \$800.00 per month as ongoing child support. This modification of the Defendant's child support obligation shall become effective June 1, 1998.

- 14. That pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed through insurance, including expenses for medical, surgical, dental, orthodontic and optical expenses, must be borne equally by both parents in the absence of extraordinary circumstances.
- 15. Plaintiff however will pay the balance of an existing dental bill which was incurred prior to this stipulation. Any future dental bills not covered by insurance will be paid as set forth in paragraph 14 above.
- 16. Defendant agrees that he shall notify the Douglas County District Attorney's Office in writing within 10 days of any change in Defendant's mailing address, home address, or employment.
- 17. Defendant understands that this support order may be reviewed every three years at the request of either party in accordance with NRS 125B.145.
- 18. Defendant understands that failure to pay his support as required by the order entered in accordance with this stipulation will subject him to possible contempt of court with a penalty of 25 days in jail.

- 19. Defendant understands that monthly periodic payments ordered in accordance with this Stipulation do not preclude the use of other means to collect any arrears or enforce this order, including garnishment, liens, attachments, execution on real or personal property or interception of federal income tax refunds.
- 20. In accordance with 125B.055, Plaintiff and Defendant shall file with the Court and with the District Attorney's Office their social security number, residential and mailing addresses, telephone number, driver's license number, and the name, address and telephone number of their employer.
