It appearing to the satisfaction of the Court that a verified petition to set aside the Nevada estate of the above-named decedent without administration has been filed, and that notice of the time and place of the hearing thereon has been duly given in the manner required by law, and that no one has objected or presented any reason why said Petition should not be granted;

The Court finds as follows:

1. WILLIAM CHARLES REEDER, a divorced man, died on July 25, 2001, in Douglas County, Nevada, leaving real and personal property situate in the State of Nevada. Decedent was a resident of Douglas County, Nevada, at the time of his death. A

period of at least thirty (30) days has elapsed since the decedent's death.

- Decedent executed his Will and Testament Last (hereinafter referred to as "the Will") on April 18, 1997; was nominated successor Petitioner, REBECCA LYNN BASTIEN, The Will directed Executrix in that Last Will and Testament. that the residue of decedent's estate be distributed to CYNTHIA REEDER, who was married to the decedent at the time he made his said Will on April 18, 1997. The decedent and CYNTHIA REEDER divorced in February 1998; therefore, pursuant to NRS 133.115, every devise, beneficial interest or designation to serve as personal representative given to CYNTHIA REEDER (now Cynthia Davis) in a will executed before the entry of the decree of divorce is revoked, and the Will takes effect in the same manner as if CYNTHIA REEDER (now Cynthia Davis) had died before the decedent herein died. Therefore, because the decedent's last Will must be read consistently with that mandate, the Court finds, pursuant to paragraph 3.4 of the decedent's last Will, that the decedent designated REBECCA LYNN BASTIEN as the decedent's first alternate devisee and legatee, and, as such, REBECCA LYNN DANIELS Bastien) (née is the decedent's and legatee and the only person eligible under devisee decedent's last Will to serve as his personal representative.
- 3. Petitioner REBECCA LYNN BASTIEN was married to Darren Daniels on August 4, 2001, whereupon she assumed the surname Daniels. Petitioner is a resident of Gardnerville, Nevada, and over the age of eighteen (18) years.

4.	Petitioner is familiar with decedent's personal and
financial	affairs. The decedent died with an estate in Nevada
the gross	value of which, after deducting any encumbrances
does not e	exceed FIFTY THOUSAND DOLLARS (\$50,000).

- 5. The property left by the decedent in the State of Nevada consists of the following real and personal property:
- 1. Lot 27, as shown on the map of Carson Valley Estates Subdivision Unit No. 1, filed in the Office of the County Recorder of Douglas County, Nevada, on July 19, 1965, in Book 33, Page 19, Document No. 28834. Assessor's Parcel No. 1220-04-510-010. APPRAISED VALUE: \$122,000 encumbered by first deed of trust: \$59,683.77; and second deed of trust: \$38,280.04; net equity: \$24,036.19.
- 2. Furniture and furnishings located at 1334 Toiyabe, Gardnerville, Nevada; approximate value: \$500
- 3. Bank Account No. 0003-1300-4434, at Bank of America in the approximate amount of \$100;
- 4. 1989 Toyota pickup, VIN JT4VN93DSK0004140; approximate value: \$1000.00;
- 5. Tools, dies, machines, prototypes, and the like, of an approximate value of \$800;
- 6. Disability payment from Maxton Manufacturing for \$2,350 which has been deposited into estate account No. 004963896399 at Bank of America;
- 7. Last paycheck from Maxton Manufacturing for \$93.23 which also been deposited into estate account No. 004963896399 at Bank of America; and
- 8. Miscellaneous personal property, such as clothing, jewelry, and the like, of nominal value, not exceeding \$500.

Total: \$29,379.42, more or less.

Thus, the gross value of the decedent's estate, less encumbrances, does not exceed the sum of FIFTY THOUSAND DOLLARS (\$50,000).

6. The following payments are due to be paid to others from the decedent's estate: (1) funeral expenses; (2) expenses

of last illness; (3) money owed to Department of Human Resources as a result of payment of benefits for Medicaid; (4) debts justly due and owing to other creditors.

The Court further finds that, in connection with the preparation, filing, and processing of the Petition in this case, which relates to transferring ownership of the decedent's interest in the above-referenced real and personal property to matters relating directly all REBECCA  $ext{LYNN}$ BASTIEN, and thereto, the law office of GEORGE M. KEELE, ESQ., has provided to Petitioner in excess of 9.5 hours of legal services at his usual and customary hourly fee of \$195 per hour, for reasonable total of ONE THOUSAND EIGHT HUNDRED FIFTY-TWO AND 50/100 DOLLARS (\$1,852.50), and that the law firm has advanced reasonable costs in the amount of FOUR HUNDRED SIXTEEN AND 24/100 DOLLARS (\$416.24), which fees and costs are necessary, appropriate, and reasonable and which should be paid by the estate to said firm; however, the firm has waived its fees, so the Petitioner shall be required to reimburse only the firm's costs in the sum of \$416.24.

The Court further finds, pursuant to section 146.070 of NRS, that this decedent's estate must not be administered upon but that the whole of the estate be assigned and set apart in the following order:

(1) To the payment of funeral expenses, expenses of last illness, money owed to the department of human resources as a

result of payment of benefits for Medicaid and creditors, if there are any; and

(2) Any balance remaining to the claimant or claimants entitled thereto pursuant to a valid will of the decedent, and if there is no valid will, pursuant to intestate succession.

The Court further finds that as the sole claimant entitled thereto, this is a proper case for the whole of the decedent's estate to be set aside to REBECCA LYNN BASTIEN, pursuant to NRS 134.100 and pursuant to the Last Will and Testament of the decedent, dated April 18, 1997, which has been reviewed by the Court.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that the whole of the Nevada estate of said WILLIAM CHARLES REEDER, also known as WILLIAM C. REEDER, deceased, including all right, title and interest owned or held by the decedent on the date of his death in the real and personal property more particularly described as follows:

- Lot 27, as shown on the map of Carson Valley Estates Subdivision Unit No. 1, filed in the Office of the County Recorder of Douglas County, Nevada, on July 19, 1965, in Book 33, Page 19, Document No. 28834, Assessor's Parcel No. 1220-04-510-0101 subject to all liens and encumbrances against said real property;
- 2. Furniture and furnishings located at 1334 Toiyabe, Gardnerville, Douglas County, Nevada;
- 3. Bank Account No. 0003-1300-4434, at Bank of America;
- 4. 1989 Toyota pickup, VIN JT4VN93DSK0004140;
- 5. Tools, dies, machines, prototypes, drawings, and the like;
- 6. All principal and accrued interest in estate account No. 004963896399 at Bank of America; and
- 7. Miscellaneous personal property, such as clothing, jewelry, intellectual property rights, and the like.

  - (3) money owed to Department of Human Resources as a result of payment of benefits for Medicaid;
  - (4) debts justly due and owing to other creditors;
- B. the law office of GEORGE M. KEELE, ESQ., the sum of FOUR HUNDRED SIXTEEN AND 24/100 DOLLARS (\$416.24) as reimbursement of its costs advanced in this matter.

IT IS FURTHER ORDERED that no further administration need be undertaken in this estate.
