
THAT, WHEREAS, RURAL NEVADA DEVELOPMENT CORPORATION,

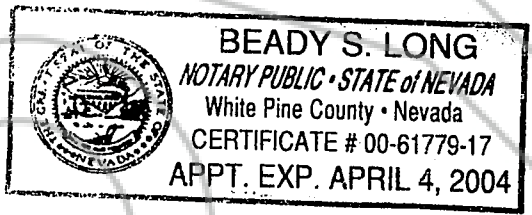
