
**SUBSTITUTION OF TRUSTEE AND



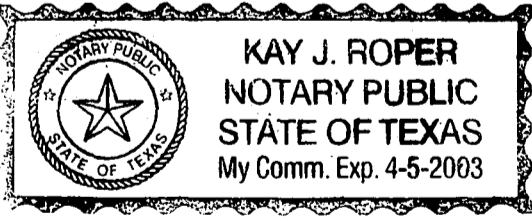


