Whereas, on October 20, 1998, Douglas County, a political subdivision of the State of Nevada, and R.O. Anderson Engineering, Inc., an independent contractor, entered into a contract for Contractor to provide engineering services to provide a sewer master plan update, geotechnical investigation, design surveying, hydraulic modeling, engineering design, and easement documents for the Foothill Sewer Project; and

Whereas on November 4, 1999, the Board of County Commissioners and Douglas County Redevelopment Agency approved Amendment No. 1 to provide additional engineering services and design efforts to evaluate an alternate north alignment for the sewer collection system, and coordinate GTE facilities; and

Whereas on August 3, 2000, the Board of County Commissioners and Douglas County Redevelopment Agency approved Amendment No. 2 to provide additional engineering services and design efforts to evaluate a sewer alignment along Genoa Lane, US Highway 395, Airport Road, and Heybourne Road; and

Whereas, on January 4, 2001, the Board of County Commissioners and Douglas County Redevelopment Agency approved Amendment No. 3 to include compensation for Task 11 -Permit Applications; and

Whereas, on January 4, 2001, the Board of County Commissioners and Douglas County Redevelopment Agency approved Amendment No. 4 to include compensation to prepare construction drawings and specifications to slip line approximately 2,600 feet of existing sewer force main within Genoa Lakes Subdivision; and

Whereas, the Contractor was required to provide engineering services to prepare final design drawings and specifications for site modifications to the Genoa Lakes Clubhouse lift station as outlined in Exhibit A as a result of easement negotiations with the Golf Club at Genoa Lakes; and

Whereas, the Contractor will provide additional construction phase services to assist with submittal reviews and startup and testing of facilities; and

Now, therefore, in consideration of the agreements herein made, the parties mutually agree as follows:

Contractor agrees to prepare final design drawings and specifications for site modifications to the Genoa Lakes Clubhouse lift station as outlined in Exhibit A; and at a cost not to exceed a total cost of \$6,100.00.

- Contractor agrees to provide additional construction phase services as authorized by the County under Task 7 – On-Call Construction Services. An additional \$10,000 is allocated to this task. Billings under this task shall not exceed \$20,950.
- Total compensation for the original contract and this amendment shall not exceed a total cost of \$556,966.50, and is summarized as follows:



Dear Ron:

This letter is provided in response to your request to Kent Neddenriep to assist in the redesign in the site plan and location of facilities at the clubhouse lift station. It is my understanding that these redesign efforts are being required as a result to the easement negotiations with the developer of Genoa Lakes. With your authorization we have already undertaken to prepare preliminary sketches of modifications to the site plan, which sketches you, are currently utilizing to facilitate those negotiations.

The formal construction drawings and details necessary to provide the contractor for what we anticipate to be a change order to his contract will require additional design efforts. At this time we are prepared to proceed with those design efforts upon your approval of this scope of services.
