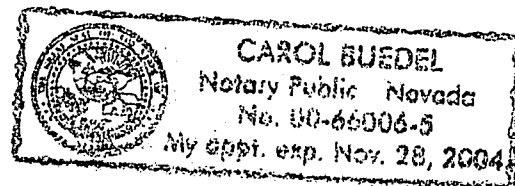


EXHIBIT "A"

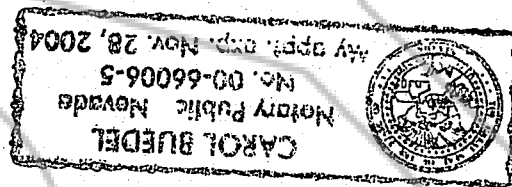
