RELOCATION OF EASEMENT

This indenture, made and entered into this 7th day of November, 2001, by and between ELK POINT LLC, hereinafter referred to as Grantor, and ELK POINT LLC, hereinafter referred to as Grantees, whose address is 223 Poinsetia, Post Office Box 612, Corona Del Mar, California 92625;

WITNESSETH

That for and in consideration of the sum of One Dollar (\$1.00), lawful money of the United States of America, (and other good and valuable consideration), the Grantors hereby grant to the Grantees, their successors and assigns, a permanent easement 25 feet wide for private access purposes, together with other necessary or convenient appurtenances connected therewith, across, over, and upon the following described lands and premises, situate in the County of Douglas, State of Nevada:

The purpose of this deed is to relocate the existing easement as shown in Grant of Easement by Grant Barbour and Loring Sagan, recorded on May 12, 1999, Document No. 467836, Book 0599, page 2227, in the Douglas County Records Office.

Grantors agree that no buildings or structures shall be placed upon, over, or under said easement, now or hereafter without the express approval of the Grantees, except that said parcel may be improved and used for street, road, landscape, or driveway purposes, insofar as such use does not interfere with its use by Grantees for the purposes for which this easement is granted.

A 25 foot wide private access and public utility easement located within a portion of the Southeast one-quarter of Section 26, Township 12 North, Range 19 East, M.D.M., Douglas County, Nevada, being more particularly described as follows:

BEGINNING at a point on the Southwesterly right-of-way line of Foothill Road, as shown on the Record of Survey to Support a Lot Line Adjustment for Grant Barbour, Loring Sagan and Frank G. & Marjorie W. Geesaman, Document No. 512214 of the Douglas County Recorder's Office, said point bears N. $38^{\circ}37'34''$ W., 2,615.87 feet from the Southeast corner of said Section 26;

thence S. $43^{\circ}25' 51''$ W., 435.58 feet;

thence S. $50^{\circ}47' 15''$ W., 122.09 feet;

thence 81.75 feet along the arc of a curve to the right having a central angle of $41^{\circ}38'08''$ and a radius of 112.50 feet, (chord bears S. $71^{\circ}36'20''$ W., 79.96 feet) to a point on the California and Nevada State line;

thence N. $48^{\circ}38'03''$ W., along said State line, 70.71 feet;

thence 123.06 feet along the arc of a curve to the left having a central angle of $80^{\circ}34'41''$ and a radius of 87.50 feet, (chord bears S. $88^{\circ}55'24''$ E., 113.16 feet)

thence N. $50^{\circ}47'15''$ E., 120.48 feet;

thence N. $43^{\circ}25'51''$ E., 433.99 feet to a point on said right-of-way line;

thence S. $46^{\circ}31'52''$ E., along said right-of-way line, 25.00 feet to the POINT OF BEGINNING.

Containing 16,210 square feet more or less.

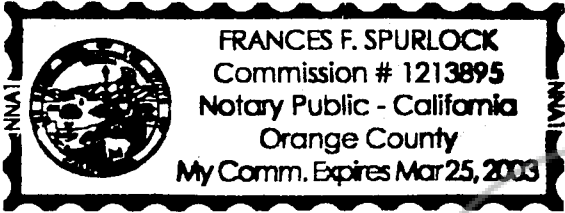
