24 responsible parent.

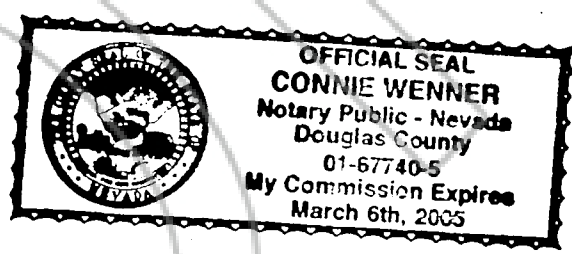

15 THIS MATTER came before the court for hearing October 2,  
16 2001, upon application by the Douglas County District Attorney's  
17 office on behalf of Troy Martin Shadle for defendant Joanni Lee Allen  
18 to appear and answer why she should not be held in contempt of court  
19 for failing to pay child support as required under the order of the  
20 Ventura County Superior Court of California filed December 1, 1998.  
21 Defendant Joanni Lee Allen appeared in person with her boyfriend  
22 Jessie Spriggs, but otherwise unassisted with counsel. The Douglas  
23 County District Attorney's office was represented by Evan Beavers,  
24 Deputy District Attorney.

25 Mr. Beavers presented evidence that the defendant is in  
26 arrears through the date of hearing in the amount of \$8,547.00 and  
27 that pursuant to the 1998 Ventura County, California order she is  
28 obligated to pay \$231 in ongoing support. In her defense the

1 defendant explained to the court that she suffers from severe  
2 dysplasia which prevents her from working, that she has two teenage  
3 daughters at home with her and that her entire household is supported  
4 by Mr. Spriggs. Mr. Beavers explained that because the defendant's  
5 employment had been so sporadic in the past, she has no driver's  
6 license to suspend, and she has made no contact with the child support  
7 office, it was the recommendation of the district attorney's office  
8 for the defendant to be placed in custody for contempt.

9 Based upon the evidence presented and the arguments offered  
10 the court finds that Joanni Lee Allen is in contempt for failure to  
11 pay child support pursuant to the Ventura County, California order of  
12 December 1, 1998, and

13 IT IS HEREBY ORDERED that judgment shall be entered against  
14 JOANNI LEE ALLEN in the amount of \$8,547 for arrearages through the  
15 date of the hearing and that she be sentenced to twenty (20) days  
16 incarceration in the Douglas County Jail for contempt, which sentence  
17 is suspended in favor of the following conditions:

- 18 1. The defendant and Jessie Spriggs shall both cooperate fully  
19 with the Douglas County District Attorney's Child Support  
20 office and prepare and present all documents, including  
21 financial declarations, before leaving the courthouse;
- 22 2. Within two (2) days of the date of the hearing the  
23 defendant shall provide both this court and the district  
24 attorney's child support office proof of any medical  
25 condition which might prevent her from working, the exact  
26 nature of her disability and proof as to when that  
27 disability first affected her ability to earn any income;

- 1 3. Defendant shall pay \$231 on or before the first of every  
2 month as ongoing child support;  
3 4. Defendant shall pay \$23 on or before the first of every  
4 month toward arrearages through the date of the hearing;  
5 5. Defendant shall provide the district attorney's child  
6 support office with her current phone number, physical  
7 address, mailing address and employment information at all  
8 times.

9 If defendant provides sufficient evidence of a medical excuse for  
10 her unemployment the sentence for contempt of court shall be suspended  
11 but the amount owing for arrears shall continue as an obligation for  
12 the defendant to pay.


