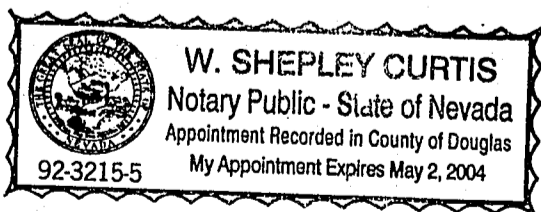

LEGAL DESCRIPTION
