


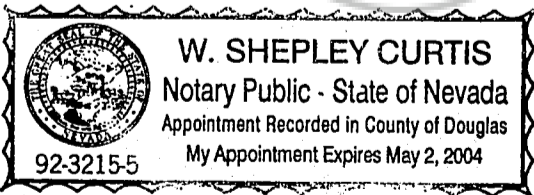

**LEGAL DESCRIPTION**
