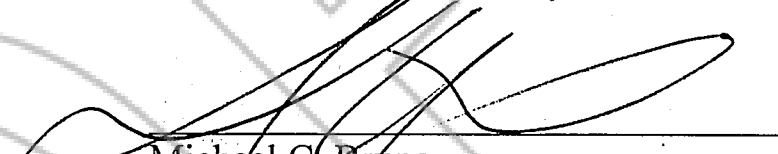
SUBSTITUTION OF TRUSTEE AND DEED OF RECOVEYHANCE

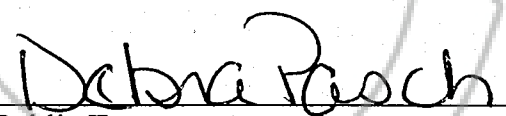
