## **SUBORDINATION AGREEMENT**

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

A. On <u>SEPTEMBER 9, 1999</u>, <u>WILLIAM M. KNERR AND CHARNA KNERR</u> ("Trustor") executed a deed of trust ("Existing Deed of Trust") in favor of <u>BANK OF AMERICA, NT&SA, A NATIONAL BANKING ASSOCIATION</u> ("Existing Lender"), covering the following real property located in the County of DOUGLAS, Nevada. 
